

Coronavirus. The latest prevention measures updated to the Prime Ministerial Decree of 11 March 2020.

MAIN OBJECTIVE: TO AVOID ASSEMBLIES AND TO LIMIT AS MUCH AS POSSIBLE DISPLACEMENTS WHICH ARE NOT NECESSARY JUSTIFIED FOR WORK REASONS, HEALTH REASONS AND PRIMARIAL NEEDS (e.g., FOOD SUPPLYING).

The measurements are valid until March 25, 2020

We are waiting for some further information from the Emilia Romagna Region board which we will give detailed update.

BUSINESS ACTIVITIES

Both for small business activities and for the medium and large-scale distribution, including shopping centers, ARE ALLOWED only the sale of food and basic necessities activities indicated below, provided that access is allowed to sole predicted activities and always ensuring the interpersonal safety distance of 1 meter:

Hypermarkets

Supermarket

Discount shops of food

Minimarkets and other non-specialized food shops

Retail sale of frozen products

Non-specialized retail trade of computers, peripherals, telecommunications equipment, audio and video consumer electronics, household appliances

Retail sale of food, beverages and tobacco in specialized stores (ateco codes: 47.2)

Retail sale of automotive fuel in specialized stores

Retail IT and telecommunications equipment (ICT) in specialized stores (ateco code: 47.4)

Shops of ferramenta, paintings, flat glass and electrical and termoidraulico material

Retail sale of sanitary equipment

Shps of articles for the illumination

Retail sale of daily newspapers, journals and periodicals

Pharmacies

Retail sale in other specialized stores of medicines not subject to medical prescription

Retail sale of medical and orthopedic items in specialized stores

Shops of articles of profumeria, produced for toletta and for the personal hygiene

Shops for pets

Shops of material for optics and photography

Retail sale of fuel for domestic use and for heating

Retail sale of soaps, detergents, polishing and related products

Retail sale of any type of product via the internet

Retail sale of any type of product via TV

Retail sale of any type of products via mail, via radio or telephone

Retail sale via vending machines

Newsagents, tobacconists, pharmacies and parapharmacies remain OPEN (ensuring the interpersonal safety distance of 1 meter). In the case of bar activities joined with a tobacconist, the bar activity must be suspended and only the tobacconist activity can be kept open.

ALL OTHER RETAIL BUSINESS ACTIVITIES ARE SUSPENDED!

MARKETS

Regardless of the type of activity carried out, all ordinary markets and market events are closed. **Only the food markets, farmers' markets and the stands of ordinary markets intended and used for the sale of food products may remain OPEN**, always guaranteeing the interpersonal safety distance of 1 meter.

FOOD AND DRINK ADMINISTRATION ACTIVITY

The activities of catering services are suspended (including bars, pubs, restaurants, ice cream parlors, patisseries). To supplement and by way of example in the list above of the suspended activities, pizzerias, kebabs, fryers, etc. must also be included.

ACTIVITIES ALLOWED:

- **catering only with home delivery** in compliance with hygiene and health standards for both packaging and transportation
- **the activity of canteens and continuous catering on a contractual basis** which guarantee the interpersonal safety distance of 1 meter.
- **the food and drink administration exercises located in the service and refueling areas located along the road, highway and inside railway, airport, lake and hospital stations,** ensuring the interpersonal safety distance of 1 meter.

ARTISAN ACTIVITIES OF PERSONAL SERVICE

Activities relating to personal services (including hairdressers, barbers, beauticians) are suspended. CAN ONLY REMAIN OPEN: laundry and cleaning of textile and fur articles, industrial laundries, other laundries, dry cleaners, funeral services and related activities.

BANKING, FINANCIAL, INSURANCE AND AGRICULTURAL ACTIVITIES

Banking, financial and insurance services as well as the activities of the agricultural, livestock and agro-food processing sector, including the supply chains that supply goods and services, are guaranteed in compliance with hygiene and health regulations.

PRODUCTIVE ACTIVITIES AND PROFESSIONAL ACTIVITIES

With regard to **production activities and professional activities (which remain permitted)** it is recommended that:

1. maximum use is made by companies of agile working methods for activities that can be carried out at home or remotely;
2. holidays and paid leave for employees as well as other instruments provided for in collective bargaining are encouraged;
3. the activities of the company departments not indispensable for production are suspended;
4. adopt anti-contagion safety protocols and, where it is not possible to respect the interpersonal distance of 1 meter as the main containment measure, with the adoption of individual protection tools;
5. sanitization operations in the workplace are encouraged, including by using forms of social safety nets for this purpose;
6. for production activities only, it is also recommended that movements within the sites are limited as much as possible and access to common areas is limited;

ACCOMMODATION FACILITIES

The accommodation facilities (hotels, residences, holiday farms, tourist villages, campsites, hostels and bed & breakfasts) can remain OPEN and within them, catering services are allowed only for customers who stay there.
